SWIM MEET CONTRACT

As one of the families that will enjoy the benefits of belonging to Socal Aquatics, the following facts concerning the financial significance of well-run swim meets are worthy of your recognition:

- I. Socal Aquatics funds its activities from two main sources. The first source is the yearly registration and monthly dues you have agreed to pay. The second source is the hosting of three to four large swim meets each year.
- II. It takes many people to run EACH SESSION of every meet we host!! The presence and participation of **EACH FAMILY** is ALL THAT ASSURES CONTINUANCE OF SUCCESSFUL RESULTS.
- III. The club membership has indicated a strong preference to the board for hosting swim meets versus alternative fund raising methods.
- IV. Socal has the reputation of hosting the best meets in Southern California. The following conditions are part of your agreement to be a member of the Socal Aquatics:

1. The board of directors will communicate with the membership the required number of sessions each family is to work for each meet.

2. Each Family will provide workers to satisfy the meet requirements set by the board. **(One full day or two half day sessions)**

3. Socal Aquatics hosts three to four swim meets per year. This year meets are on the following weekends:

January 2014 November 2014

4. If a family cannot attend one of the above meets it is their responsibility to make arrangements ahead of time with the Meet Manager to assist either prior to or after the conclusion of the meet.

5. At each meet there will be a registration table for you to "sign in" when you arrive at the pool. It is your responsibility to make sure that you have signed in properly.

6. Failure to satisfy the requirements spelled out above in conditions #2 and #4 will result in a **one hundred dollar (\$100.00) assessment per session** not worked by that family for each meet.

7. After you have paid the assessment, you will be allowed to "make-up" your missed sessions at the next meet of the current year and have your money returned. (A year is defined as meets held between September 1 through the following August 31).

8. All families will be responsible for a one hour timing assignment at all away meets attended.

SERVICE FEES CONTRACT

Socal Aquatics Association

1. The annual club registration and USA Swimming registration fees must be paid prior to the swimmer entering the water and are not refundable. New swimmers to Socal Aquatics will be charged a \$75 registration fee. Additional family members pay \$25. Annual renewal is \$25 per swimmer and will be added to your monthly invoice.

2. MONTHLY DUES ARE BILLED IN **ADVANCE** ON THE FIRST DAY OF THE MONTH AND ARE CONSIDERED LATE IF NOT RECEIVED BY THE FIFTEENTH DAY OF THE THAT MONTH. A SWIMMER WHO'S FEES ARE LATE WILL NOT BE PERMITTED IN THE WATER UNTIL PAYMENT IS RECEIVED.

3. Periodic review may allow a swimmer to be moved from one group to another. In this circumstance they will be billed at the higher rate if they swim a minimum of three swim days in that group. Please see separate fee schedule for current monthly fees. A family fee cap of \$225 per month is available to families with three or more swimmers.

4. Meet entry fees are in addition to the monthly dues and will be added to your monthly invoice. These fees are due and payable in the same manner as monthly dues with the same consequences for tardiness or nonpayment (see item #2 of this contract).

5. Resigning from Socal Aquatics does not alleviate you of your responsibility for any and all fees due to the team, including monthly dues, or any portion thereof, and any outstanding meet entry fees. To avoid being billed for services that you no longer want YOU MUST NOTIFY THE BILLING OFFICE, IN WRITING, OF ANY CHANGES REGARDING YOUR ACCOUNT in advance of those services being rendered.

6. Participation is a year-round membership responsibility. Swimmers that cannot participate in any given month may arrange to pay an inactivity fee of \$15.00 in Lieu of their normal monthly fees.

7. A \$15.00 handling fee will be assessed for each check returned unpaid by the issuer's bank.
